# **Approval of Minutes:**

### **KACO**

Spoke to the Court about Bonds for Road Bridge Projects. The Court will review this information. No decision was made at this time regarding bonds.

## Road

A motion by Stonnie Dennis, second by Jody Brown, unanimous on vote to enter into contract with Jim Smith Construction for \$163,253.98 substructure repairs project for Fraser Road bridge #17.

### **EM**

#### **Ambulance**

A motion was made by Nathan Whipple, second by Chip Bisson, unanimous by all to approve \$4,400 for 4 tires for the skid steer.

### **Treasurer**

Motion made by Chip Bisson, second by Nathan Whipple, unanimous by all to approve 4.46 one year CD interest rate presented by First Community Bank.

An amended motion made by Jody Brown, second by Chip Bisson, unanimous by all on to close out CDBG Utility grant and to allow J/E Todd Cooper to sign out the grant.

Motion made by Stonnie Dennis, second by Stonnie Dennis, unanimous by all on approval to pay bills.

# **County Attorney**

Bethany Denton gave an overview of County Ordinance 430.5, a second reading rescinding Ordinance 430.4, Occupational tax abatement for TN America's, LLC. A motion was made by Jody Brown, second by Chip Bison, unanimous by all, to approve County Ordinance 430.5 rescinding the 10 year Occupational Tax Abatement Ordinance 430.4 for Daher-TLI.

Discussion about a draft UTV Ordinance was discussed by community members and the court. No action was taken at this time.

# **County Clerk**

It was noted that the County Clerk wrote a personal check to the County in response to the State's 2021 audit findings. J/E Todd Cooper also reported that Mary Warford, Chief Deputy for the Co. Clerk's office has gone back to 2019 to make ensure that the office is correcting the issues. He assured the Court that the

County Clerk is doing her "due diligence" and asked the Court for an "open end" time frame. The Court agreed.

## **County Coroner's Office**

Motion made by Jody Brown, second by Ryan Hedrick, unanimous by all to approve hourly rate of pay for Deputy Coroners.

## **Projects and Properties**

Judge Cooper discussed a grant award by the Ky Cabinet for Economic Development for the West Ky Riverport in the amount of \$300,000. It is a 50/50 grant. A motion by Stonnie Dennis, second by Chip Bisson, unanimous by all to move the remaining ARPA money from resolution 2021-ARPA-9-3 to the West Ky Riverport Authority, in the amount of \$60,000.

Judge Cooper discussed the need to partner with Barlow to pave Moore Blvd, as two new businesses and housing was being planned for the property. Barlow is the poorest city in the County. The request was to pay 1/3 of the cost of paving, in the amount of \$15,000. No action was taken at this time.

A quote from BTC is being sought for the Courthouse. The current phone system is a 1996 model and is one lightning strike away from no longer working. The quote is not available yet.

# <u>Jail</u>

A motion by Stonnie Dennis, second by Nathan Whipple, unanimous by all to approve the amended 36-month inmate phone contract with CPC.
