Tod and Travis reported on the condition of the buildings on the property of interest on Lake Drive in Barlow. Tod gave his monthly report on progress of the department.

Sheriff

Tax bills will be turned over to the County Clerk's Office on April 16, 2025. Ronnie gave an update on the FLOCK cameras. Pilot program with 7 cameras will begin in June or July. Pilot program is 60 days. His department will be able to fund part of them and will contact the individual cities to help with the cost. He will keep at least 3 cameras at a cost of \$3000 per camera per year.

Jail

Eric Coppess presented the Jail report. The average population for the month was 98, 52 bookings with 43 releases. Housing income was\$ 71191 and MRT income was \$22000.

Dispatch/911

Calls are not being routed directly to River County 911 yet but hopefully it will be soon that the line will go directly to dispatch in Carlisle.

Pager tests are not happening with any consistency. Todd will step down from the 911 Board the Court will appoint a new member. Chip Bisson will become the new member of the 911 Board.

Ambulance

A written report was presented by Anna Abernathy. Collections were approximately \$13,000 for the month of March.

Motion by Nathan Whipple second by Jody Brown and unanimous on vote to approve the increase in pay for MW for becoming a Certified Paramedic upon receiving the certificate.

EMA

Travis Holder asked the court to inspect road issues/washouts due to the recent storms and tornado. If there is a road that has been washed out or needs a new culvert, etc. please notify Travis or Judge Executive's office.

Judge Clymer sent a letter of accolades for the first responders in the response to the incident involving the death of Lee Chandler in the floodwaters.

Animal Control

A draft lease was presented for the Animal Shelter. April's Grooming is being sold. The Shelter will be changing owners and names.

Solid Waste

Bryan presented his monthly report. During Free Week there was 60T collected. A load of cardboard was sold, waiting on that check approximately \$2000, and intake was \$6849.

Any resident with tornado damage for 30 days the center will intake any construction material.

Five (5) certified letters went out to home owners that need property clean-up. Three properties have made some progress 1 will get another letter and the 5th will move forward with criminal summons.
